Dear ladies and gentlemen,

We inform you in the following about upcoming changes in Nabisy as well as about other innovations:

- 1. Adjustments regarding the security requirements in Nabisy (Expected at the 09.03.2021).
- 2. Discharge accounts
- 3. Miscellaneous (review; outlook on the implementation of RED II)

Re 1. Adjustments regarding the security requirements in Nabisy (Expected at the 09.03.2021).

We will implement with the next Nabisy - update, probably on 09.03.2021, some security adjustments in Nabisy, which affects all user groups in Nabisy.

a. Initial registration to a new account

You have received the user name and password from the BLE by post. When you log in to Nabisy for the first time, you will automatically be requested to change the password. You cannot continue in Nabisy without assignment of a new password.

However, you should keep the letter with the password assigned by BLE safe, as we can reset your account to the initial password in case you forget current your password.





- b. New password required on a regular basis
 All user groups must set a new password for their personal account
 every 90 days according to the password rules (see below). If an account
 is not used for more than 90 days, the new password will be required
 the next time you log in. You will not be able to continue in Nabisy
 without assigning a new password.
- c. Blocking of the access after repeated wrong input of the password If you enter a password five times wrongly, your personal access gets blocked automatically. Nabisy will inform you about this. In such a case, please contact nabisy@ble.de with the following information to have the account unlocked again:
 - your name,
 - the participant ID of the company under which you wanted to log-in (e.g. EU-BM-99-SSt-1234678 or EU-BM-88-Lfr-87654321) and
 - the information whether you still know your last assigned password.

We can then unlock your access so that you can reuse your last assigned password.

- d. You have forgotten your password
 In such a case, please contact us at nabisy@ble.de with the following information
 - your name
 - the participant ID of the company under which you wanted to log in (e.g. EU-BM-99-SSt-1234678 or EU-BM-88-Lfr-87654321) and
 - the information whether you still know the password assigned by the BLE.

We can then reset your password to the one assigned by the BLE. If you do not have the letter with the initial password any longer, the BLE will assign you a new password and send it to you by post. With the first login to Nabisy after the password reset you are automatically requested to change the password. You cannot continue in Nabisy without assigning a new password (one-time password).

e. Password rules

For all users the following password rules apply in Nabisy: The password

- MUST contain at least a minimum of 8 characters
- MUST contain at least 3 of the following variants
 - o lowercase letter(n) (a-z)
 - Capital letter(s) (A-Z)
 - o number(s) (0-9)
 - Special character (,,!? + etc.)
- MAY NOT contain the user name
- MAY NOT consist of repeated groups of 2 different characters (e.g.: abab; 10102323)
- MAY NOT be ascending or descending in 3 or more characters (e.g.: 123; abc; xyz)
- MAY NOT contain more than 2 identical characters in a row (e.g.: 111; aaa; !!!)


The last 10 passwords MAY NOT be used.

If your password contradicts the password rules, you receive an appropriate error message. Likewise you are informed by Nabisy whether you had already used the password and it is therefore inadmissible.

Re 2. Discharge accounts

With the next update in Nabisy (introduction of the new security requirements) we will close the DE discharge accounts. You will still have the EU discharge accounts available. You will find an updated list in the Nabisy - help or on the web page www.ble.de/biomasse in the area information regarding Nabisy.

If you should need further discharge accounts, e.g. for a further country, announce this under description of your case to nabisy@ble.de. We will either assign you an account for your case, or create a new account and inform you about the account number already before the publication.

Re 3. Miscellaneous (review; outlook on the implementation of RED II)

1. Review -10 years Nabisy

The submission of sustainability proofs from the governmental database Nabisy is mandatory in Germany since 01.01.2011, if a governmental benefit is desired (EEG remuneration for liquid biomass or avoidance of penalty payments in the fuel sector). Nabisy is an IT development by BLE that has been subject to permanent changes and adjustments since it was launched. It implements the national sustainability ordinances, which in turn implement the Renewable Energy Directive in national legislation. The integration of the increasingly important EU voluntary schemes and the connection to the Austrian database elNa were also implemented. The introduction of the additional German proof of double weighting for two years 2013/2014 - required a profound adjustment. Nabisy was and is always being adapted to new requirements by the EU and the federal government.


In the course of time, the national database has already gained more than 10,000 access-authorized persons worldwide from business and public authorities. This high number is due to the fact that a company / authority usually applies for several personal accesses for a Nabisy account.

The companies / authorities which have registered to Nabisy since 2010 are divided as follows:

Around 174,000 proofs of sustainability have been created in the Nabisy database since the beginning. From these, around 812,000 partial proofs of sustainability were created in the supply chain by transcription, dividing and, earlier, also by combining.

2. Outlook on the implementation of RED II

Currently, the questions to the BLE regarding the implementation of RED II in Nabisy are increasing. As soon as the changes of the national regulations (BioSt-NachV and Biokraft-NachV) have become applicable, it can be assumed that there will be a need for changes in Nabisy. The BLE as the operator of the governmental database will implement this accordingly and inform the users as early as possible.
